Sir,

As you are aware, Ministry of Urban Development is implementing Swachh Bharat Mission (SBM) Urban with a goal to make the country clean and open defecation free by 2<sup>nd</sup> October, 2019. One of the important components of SBM is capacity building of all city-level and state-level officials and other staff working for the Mission.


2. To effect substantial improvements in the programme for implementing all components of the mission, it is necessary to build the capacities of all relevant stakeholders, including Municipal Commissioners, Municipal Engineers, Health Officers, and Sanitary Inspectors etc. through exposure to new concepts and technologies in the field of sanitation and waste management.
3. MoUD is playing a facilitating role in identifying the best practices carried out in selected municipal corporations, and ensuring that officials from other municipal corporations should undertake exposure visits to these selected ULBs, to have a first hand exposure about these best practices for replicating them in their respective cities. This will ensure peer to peer learning, sharing of best practices among officials from different regions of the country and ensuring effective implementation of various components of Swachh Bharat Mission.
4. Under this initiative, exposure visits to the cities of Coimbatore, Agra, Greater Mumbai, Pune, East Delhi Municipal Corporation, Ahmedabad, Jabalpur and Panchgani, are being planned from 19th of August to 30th November, 2016. The training calendar, indicating the tentative dates and themes for these sessions, is enclosed at Annexure I. The batch size for each of these training sessions is tentatively being restricted to 30 persons and is likely to increase only as per the discretion of the respective Municipal Corporations.
5. To ensure that your city is benefited from the exposure visits, you are requested to nominate two staff members from your Municipal Corporation for each of these sessions and share their details with the Municipal Commissioners of the respective host cities. Contact information for requisite Municipal Commissioners is enclosed at Annexure II. Participants will be selected by the host cities on a first cum first served basis only.

6. As this will be a peer to peer learning program, the boarding and lodging of the participating cities can be met from the respective capacity building funds of the nominating cities. All participants must prepare a report on the session that they attended and share the same with their city.
