The expenses incurred in organizing this workshop can be met from the Capacity Building funds allocated under Swachh Bharat Mission.

- 4. Central Pollution Control Board (CPCB) will be providing necessary content for the training program and support program related activities and modalities in consultation with MOEF&CC and MOUD. NPC will be providing the name of Resource Persons for imparting the training, soft copies of the tool kit material, indicative nature / types of stakeholders to be invited and also help in coordinating the training support from Resource Persons.
- 5. I shall be grateful if all necessary cooperation is extended to NPC and CPCB in the implementation of this important national flagship programme.
