

**OFFICE MEMORANDUM**

Sub: National Monitors for Swachh Bharat Mission.

The undersigned is directed to refer to the subject mentioned above and to say that for the Swachh Bharat Mission, every State has nominated a Committee to oversee its implementation, monitoring etc. called the High Powered Committee to be headed by the Chief Secretary of the respective State. In this Committee, it is provided to co-opt members from the Ministry of Urban Development so that the Mission is effectively monitored at the national level. For this purpose, officers from Ministry of Urban Development have been nominated for the States as per list enclosed. The responsibility of the officers would be as under:-

- (i) Attend the State Level meetings on behalf of Ministry of Urban Development.
  - (ii) Ensure that the meetings are held once in each month.
  - (iii) Study the progress reports and to visit the designated State at least one day before the meeting to see verify at selected ULBs.
  - (iv) Take inspection formats for filling data at selected ULBs.
