Also, to ensure active participation of SIOs & DIOs from NIC in implementation of Swachh Bharat Mission, you are requested to kindly include State Informatics Officer, NIC as a member of High Powered Committee (HPC) of SBM (Urban) constituted under the chairpersonship of a State's Chief Secretary and District Informatics Officer, NIC as a member of District Level Review & Monitoring Committee (DLRMC) of SBM (Urban) constituted under chairpersonship of a Member of Parliament.

- 6. You are requested to kindly make convenient to attend this training on SBM MIS application at State Level as Chief Guest and issue necessary direction to all District Collectors to attend the training on SBM MIS application at district level as Chief Guest.
- 7. You are also requested to nominate a nodal officer from SBM State Mission Directorate to coordinate with SIO & DIOs in organizing training on SBM MIS application at State and District level.
