**Subject: Unregistered States/ UTs to register on PFMS Portal**

Respected Sir/ Madam,

As you are aware, Ministry of Urban Development is implementing Swachh Bharat Mission (SBM) Urban with a goal to make the country clean and open defecation free by 2nd October 2019.

2. In this regard, the Office of the Controller General of Accounts (CGA) has created a portal, called **Public Financial Management System (PFMS)**, formerly known as Central Plan Scheme Monitoring System (CPSMS). The portal tracks the fund disbursement, under various government schemes/missions including Swachh Bharat Mission (Urban), from Government of India till the last level of utilization on a real time basis.

3. Through this initiative we are registering States/ Union Territories, who are required to further register ULBs with their bank accounts for the payment to reach the ultimate beneficiary in a timely manner. This helps in monitoring the flow of funds from Centre to the lowest level of implementation and also enhances transparency & accountability in public expenditure.


4. Till date, 24 States/ UTs have registered and 12 States/ UTs are yet to register on PFMS Portal, as enclosed in Annexure- I & II.

5. To ensure proper and timely monitoring and utilization of funds, you are requested to register your States/ UTs on the Portal by 15<sup>th</sup> July, 2017. You may refer to PFMS Registration User Manual and PFMS FAQs booklet, as attached, for any further information.

Looking forward to your continuous support and cooperation to make Swachh Bharat Mission a success.
