Subject- Capacity Building under Swachh Bharat Mission

Dear Sir,

1. As you are aware, the Swachh Bharat Mission is gathering momentum with enthusiastic public participation and the nation appears to be on its way to achieve the twin objectives of open defecation free and neat and clean cities by 02 October 2019.
2. You will agree with me that technology will be a key consideration for the mission's ultimate success. During interaction with municipal functionaries in many states, we had noticed a lack of awareness about the latest trends in sanitation technologies, best practices and procurement procedures. There have been demands for hiring of competent professionals at state and municipal levels for which the suggested procedure has already been shared through my D.O. letter dated 17 April 2015.
3. The mission had earmarked almost Rs 609 Cr for Capacity Building and Office Expenses. The states are also to contribute Rs 205 Cr in 75:25 ratio. Consequently, roughly Rs 570 Cr would be available to states for designing their own capacity building programmes after the central share is taken out.
4. The urban population of the country being about 36 Crore, roughly Rs 16 per capita is available for capacity building during the mission period. From the amount available to the states, 50% can be retained by the State Mission Directorate while the rest is to be devolved to ULBs.
5. May, I therefore suggest that the state may start utilising the available capacity building funds by organising training programmes/ workshops at State level and providing exposure visits to municipal functionaries from the ULB share of funds. A few suggested location/ places for exposers visit are listed at Annexure 1.

6. For this expenditure, the State level High Powered Committee under Chief Secretary is the competent authority. The National Mission Directorate shall also provide support through holding of National level workshops and exposure visits.
