NOTICE

Request for Financial offer for Verification of Data under Swachh Maharashtra Mission - Urban

State Mission Directorate is the State Level Nodal Agency for Urban Development Department, Govt of Maharashtra implementation of the Swachh Maharashtra Mission (Urban). This mission envisages construction of Individual Household Latrines, Community and Public toilets and its usages towards achieving mission objectives in its true spirits. As per the mission guidelines geotagged photos of constructed toilets are uploaded on the Swachh Bharat Mission portal. Accordingly, it is requested that you submit your financial offer for the verification of data of the said uploaded photos under Swachh Maharashtra Mission (Urban).

The detailed scope of work is as follows:

Scope of Work

1. Verification of photos of constructed Individual Household Latrine uploaded by the ULBs under the mission.
2. Photo verification report must be made available to the mission in soft copy.
3. The agency is expected to verify the exact location of the uploaded images which should confirm with the Latitude and Longitude of the said image at the given location in the respective ULB through GPS location search facility.
4. The uploaded images of “under construction” and “completed toilets” must be verified with reference to their latitude/longitude location.

5. Duplicate names of the beneficiaries on the same latitude/longitude locations would need to be identified.
6. The agency will be required to provide weekly work progress report. The required link and logins must be provided to Directorate office for the required period.
7. The web server, hosting and related service must be provided by service provider only.
8. Photo verification report must be given on provided link of relevant ULB's.
9. The agency will be required to provide requisite physical support as and when required by the ULBs by visiting the said ULB. In this case the expenditure incurred for the travelling and boarding and lodging by the agency will be borne by the concerned ULB which would be limited to that admissible to Junior level Class 1 officer of state government as per the prevalent norms.
10. Photo verification and compliance report must be submitted to Directorate in the given timeline.
11. During the course of verification the agency should submit a report to the authority in case it observes any mistakes or errors in the uploading of photos.
12. Quotes are requested in this regard for the Konkan Division in the state of Maharashtra which comprises of 51 ULBs.
13. The agency will have to provide a FREE Mobile App(Application) supporting Android/ ios platform) to the concerned ULB for compliance of the errors observed.
15. Completed Online Photo verification report for the entire division must be submitted to Directorate in maximum 15 working days from the date of work order.
15. The concerned ULB will be required to submit the compliance report to the agency within maximum 10 days.
16. After receiving the compliance report the agency should again re-verify and submit the final report in the soft copy to the Mission Directorate and ULB in this regard in next 7 days.
16. During the verification process the agency will be required to download 80 - 90 % images and relevant information (Beneficiary Name, Ward, ULB name, ID, Latitude and Longitude) from SBM portal and create a new weblink to upload the requisite information.
17. The agency will be required to have experience of at least 1 year of working with the ULBs/ States/ PRIs under the Swachh Bharat Mission for activities like Uploading of photographs, geotagging **with automation** etc. The work certificate and performance certificate in this regard will have to be signed by the competent authority, in the ULBs/ States/ PRIs where the said agency has worked.

- The financial proposal in the prescribed format attached herewith in sealed envelope with “DO NOT OPEN, EXCEPT IN PRESENCE OF THE AUTHORISED PERSON”. Should reach State Mission Directorate by 10th July 2017 by 16:00 hrs. at the above said address.
- Incomplete, conditional proposals will be rejected outright without assigning any reason.
- Award of work will be at the sole decision of State Mission Directorate and no queries will be entertained regarding the selection of the agency.
