Notice for Expression of Interest for empanelment of suppliers for the supply of 'Mechanical In-vessel Shredder and Composter Assembly (MISCA)' of various capacities

1. Background/Scope of Work

About 70 to 80 per cent of urban waste is organic in nature, a significant portion of which is readily decomposable through biological processes. A desirable end product emerging from this decomposition is called compost, a soil nutrient. The process to manufacture compost is called composting. Through this process, cities and towns can mitigate their growing problem of waste management. Up to 45 per cent of the municipal waste can be converted into compost which can be supplied for use in gardens and farmlands, thus reducing the amount of waste that goes to the landfill and also reducing disposal costs for the local government.

There are a variety of techniques to manufacture compost, however to reduce the nuisance and expenses related to transportation of degradable organic matter to a common city level composting facility, the Government of India supports decentralized composting at community level. A number of ULBs have already introduced policies on source level segregation of waste (domestic as well as commercial) which also promotes decentralized composting of organic waste at the household level.

As per the Orders fo Hon'ble NGT, each ULB should have its own waste processing and disposal sites which should be developed at appropriate acceptable locations based on environmental clearances as required. Further, as per the Solid Waste Management- Rules 2016, the bulk generators producing more than 100kgs of waste per day, must possess on-site processing facilities.

Decentralised Composting- Carefully separated organic household wastes at neighborhood or ward levels can be converted into compost by use of Composter equipment. The involvement of local residents promotes awareness of resource recovery and ensures the separation of waste at household level, while creating employment opportunities. Decentralized composting approach reduces transportation costs, makes use of low-cost technologies based mainly on manual labour, and ensures waste is well sorted before it is composted. This could minimize many of the problems and difficulties that have led to the failure of large centralized composting plants. At decentralized level too, there are two main approaches to composting-

- a) **Natural Composting or pit composting-** This requires 10-12 weeks of processing time and considerable space. There is significant odour from the fresh waste and is not practical everywhere in an urban scenario.
- b) **Accelerated Mechanical Composting-** This requires a assembly of equipment to mimic and accelerate the natural processes, primarily shredders, drum mixers, heaters and storage trays.

In order to promote accelerated mechanical composting and to streamline the purchasing process for interested buyers, Nationals Seeds Corporation (NSC) proposes the following:

- Empaneling of firms (*Suppliers*) for the supply of 'Mechanical In-vessel Shredder and Composter Assembly (MISCA)'on a rate contract basis.
- Aggregating the demand (*Buyers*) for these machines among ULBs, bulk generators of organic waste including Hotels, RWAs, School/College Canteens, etc.

Roles and Responsibilities of the Key stakeholders

The key stakeholders and their roles and responsibilities are detailed below:

NSC

- On boards Suppliers of Mechanical In-vessel Shredder and Composter Assembly (MISCA)
- Finalizes rates of MISCA and its sub- assemblies, components, spares, attachments
- Finalize/Enforce warranty/guarantee frameworks
- Ensures due diligence & quality checks on buyers and suppliers
- Proof of the delivery of machine has to be ensured by NSC.

Supplier

- Supplies MISCAs to the buyers through NSC as per the rate contract.
- Commits to supply within stipulated timelines
- Provides guarantee/warranty to buyer as per terms and conditions agreed to with NSC
- Takes payment from NSC on confirmation delivery, installation and satisfactory working of the composter assemblies from buyer

Buyer

- Determines machine requirement and specifications
- Places order with NSC-100% advance payment (or other terms as deemed fit by NSC)
- Takes delivery of indented MISCAs and send confirmation/proof of the receipt, installation and satisfactory working to NSC.

2. Request for Expression of Interest (EOI)

National Seeds Corporation Limited invites Expression of Interest for empanelment of reputed market suppliers for procurement of **Mechanical In-vessel Shredder and Composter Assembly (MISCA)** (of various capacities) on rate contract basis. The period of rate contract will be valid for 1 year and may be extended as per mutual agreement.

3. Validity of EOI

The EoI shall be valid for a period of not less than 120 days from the EoI Due Date. NSC reserves the right to reject any EoI which does not meet the requirement.

4. Earnest Money Deposit (EMD)

EoIs should be accompanied by a DD of Rs. 5000/- in favor of National Seeds Corporation Ltd. payable at New Delhi towards EMD. Refund will be as per procedure.

5. Eligibility Criteria

To be eligible the applicant:

- i. Shall be an authorized dealer/distributor/manufacturer of 'Mechanical In-vessel Shredder and Composter Assembly (MISCA)'. Only reputed dealer/distributor/manufacturer with good profile will be eligible for empanelment.
- ii. Should not have been blacklisted or debarred from participating in tenders by any Central / State Government agencies or autonomous bodies or universities/institutions. (An undertaking to this affect should be furnished)

6. Brief description of the Selection Process

Machine models will be shortlisted based on this assessment. The firms, whose composter assemblies have been shortlisted at this stage will thereafter be invited to submit detailed financial proposals (formats and requirements for which shall be circulated at a later date).
